

**CAPTAINS, PLEASE NOTE CHANGES TO THE
2013 TOURNAMENT RULES**

RULE 3: ELIGIBILITY

LINE 2 (MUST HAVE 21 GAMES OR MORE BY JANUARY 1, 2013)

**THIS RULE DOES NOT APPLY TO NEW JERSEY RESIDENTS WHO ARE UNDER THE
JURISDICTION OF A NEW JERSEY STATE AFFILIATED LOCAL USBC BA OR MERGED
ASSOCIATION FOR THE 2012/2013 SEASON**

NJ STATE BOARD MEMBERS

AND PARTICIPANTS IN THE

AND NJ STATE SENIORS TOURNAMENT IN 2011 & 2012

NOTE: TOURNAMENT RULE 5 G

**HAS BEEN CHANGED TO READ (BOWLERS WHOSE AVERAGE WAS ESTABLISHED IN A PBA OR
CHALLENGE PATTERN CONDITION) MAY FACE RERATING BY THE TOURNAMENT
MANAGEMENT. IN ANY CASE, THE BOWLER OR BOWLERS HAVE THE RIGHT TO APPEAL THE
RERATING TO THE USBC OFFICE WITHIN 10 DAYS
OF THE DATE OF BOWLING OR PRIOR TO THE PAYMENT OF PRIZES, WHICH EVER COMES
FIRST (USBC RULE 319C)**

**PLEASE NOTE ANY OUT-OF-STATE BOWLERS WHO ARE ELIGIBLE FOR ANOTHER STATE'S
ASSOCIATION CHAMPIONSHIP TOURNAMENT, MUST BOWL 21 GAMES AS OF JANUARY 1, 2013
IN A LEAGUE WITHIN THE JURISDICTION OF THE NEW JERSEY STATE USBC ASSOCIATION, TO
BE ELIGIBLE TO PARTICIPATE IN THIS TOURNAMENT. THEY, HOWEVER MUST STILL USE
THEIR HIGHEST USBC AVERAGE FOR ENTERING THIS TOURNAMENT**

**A PROFESSIONAL BOWLER LIVING WITHIN THE JURISDICTION OF THE NEW JERSEY STATE
USBC ASSOCIATION IS ELIGIBLE TO PARTICIPATE IN THIS TOURNAMENT AS FOLLOWS:**

- 1. ONLY 2 EXEMPT PROS MAY BOWL ON A TEAM EVENT**
- 2. ONLY 1 EXEMPT PRO MAY BOWL ON A DOUBLES EVENT**
- 3. THEY MUST HAVE A CURRENT 2012/2013 MEMBERSHIP CARD WITH A NJ AFFILIATED
USBC BA OR MERGED ASSOCIATION**
